- #1 SAFE PASSAGE - 6 mph within 150 feet of other vessels (RSA 270-D:2, VI)
- #2 BOATING WHILE INTOXICATED (RSA 270:47 THROUGH RSA 270:58-b)
- #3 HEADWAY SPEED - 6-mph (RSA 270-D:1, VI AND RSA 270-D2, VI)
- #4 SAFETY EQUIPMENT - PDF for all occupants; fire extinguisher for all power boats; horn or whistle (SEE SAF-C 400)
- #5 NAVIGATIONAL LIGHT REQUIREMENTS (SEE SAF-C 400)
- #6 THE REGISTRANT OR RENTER IS RESPONSIBLE FOR ANYONE WHO OPERATES THE VESSEL (RSA 270-D:2-c, II (b)).

YOU ARE ALSO REQUIRED TO ACKNOWLEDGE THAT THE DIRECTOR OF SAFETY SERVICES MAY REQUIRE THE REGISTRANT OR THE OPERATOR TO ATTEND A SAFE BOATING COURSE.

2. If this application is for a boat that has temporary or permanent sleeping facilities (houseboat) and it will be moored at one location in New Hampshire, please state where it will be moored. Otherwise notification of places of mooring of houseboats to New Hampshire Water Supply & Pollution Control Commission is required in accordance with provision of RSA 270-A.
